

Low voltage fast-switching PNP power transistor

Preliminary Data

Features

- Very low collector to emitter saturation voltage
- High current gain characteristic
- Fast-switching speed
- Surface-mounting DPAK (TO-252) power package in tape & reel (suffix "T4")
- Through-hole IPAK (TO-251) power package in tube (suffix "-1")

Description

The device is manufactured in PNP Planar technology by using a "Base Island" layout. The resulting transistor shows exceptional high gain performance coupled with very low saturation voltage.

- High efficiency low voltage switching applications

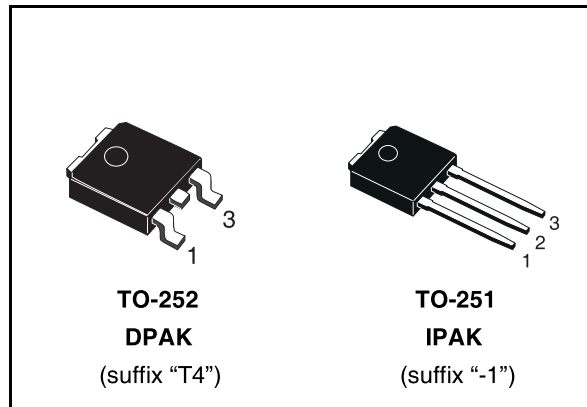


Figure 1. Internal schematic diagram

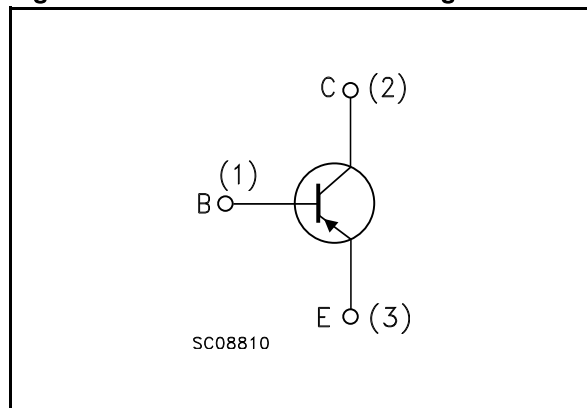

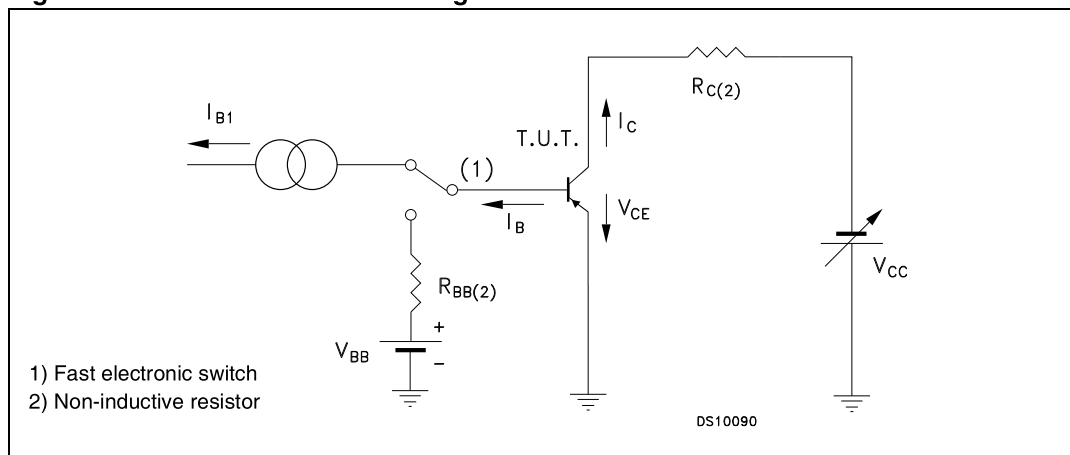

Figure 2. Resistive load switching test circuit

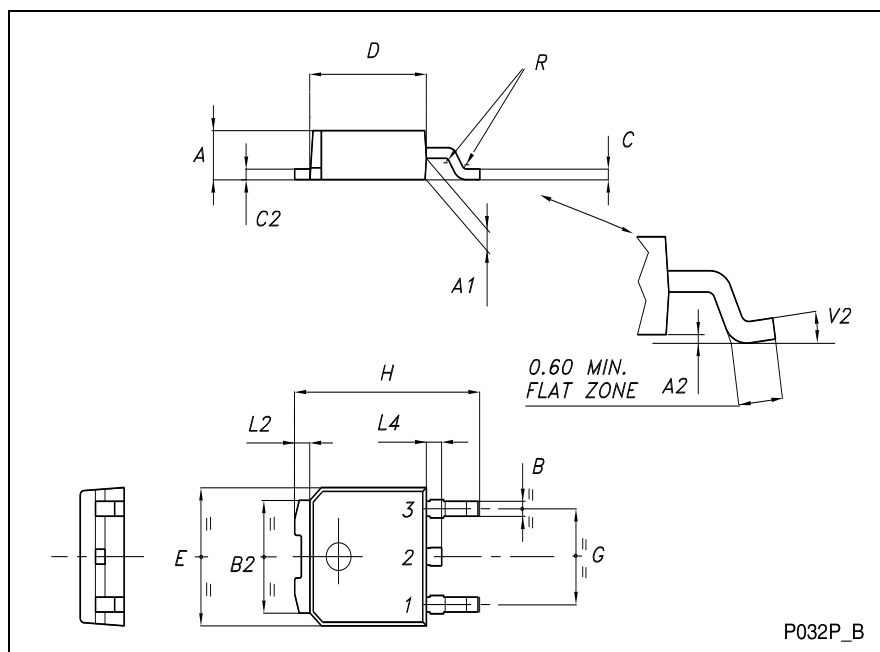


3 **Package mechanical data**

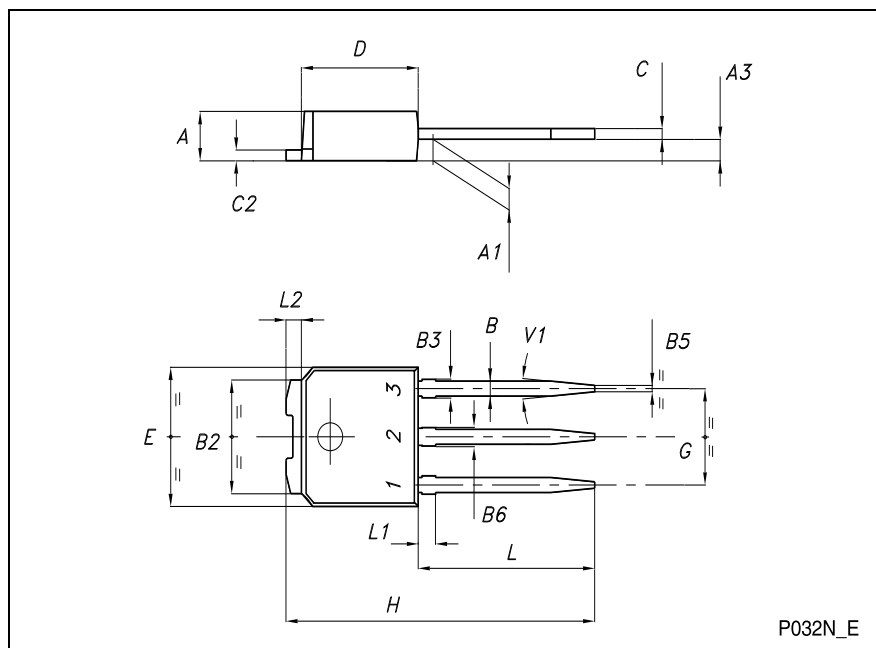
